Chief Examination

I am residing at Sve Dame community in Auroville. I am currently the guest house manager of Sve Dame community in Auroville. LW1 Hye Jeong heo is my wife. At present she is residing in South Korea. She was residing in the said community since 2001 and left in the year 2021 end of March or at the beginning of April.

On 22-02-2020 as she was a co-ordinator in the community She was on her way to the community at about 11.30 to 12.00 Noon she was assaulted by our neighbour Louie who is currently present in the court. Regarding the assault my wife

lodged the complaint with Auroville Police in which she has clearly stated about the incident that has happen on that day. She told me about the incident. At the time of incident I was actually at Pondicherry. My wife phoned me about the incident. After knowing about the incident , I immediately rushed to the Town Hall where there was a Auroville Council, Which deals with the incident that happended in the community. I accompanied with her to the police station. The signature found in the Complaint is the signature of my wife. I am aware of the contents of the complaint. In the signature found in the complaint as marked as Exhibit P1. Police enquired me about the incident.

Cross Examination

It is correct to say that Sigrid, Daniel, Dariya, Harment, Thomozo, Madhu resided at Sve Dame community at the time of the incident. It is correct to say that on 22-02-2020 after the incident my wife herself went to the council and I did not take her. It is correct to say that My wife did not go to the police first rather went to the council immediately.

It is correct to say that My wife lodged the complaint with the Auroville Police on 27-02-2020. Whether I have a proper marriage certificate to prove that I am married to my wife? Our marriage is registered in Germany under german law. We have not registered our marriage as per indian laws. It is true that When the incident took place i was at pondicherry, So I didnot witness the incident.

It is incorrect to say that in order to support my wife's Complaint, I have come with the false statement before this court.
