This petition coming on this day before me for hearing in the presence of Thiru.A.Karthikaivel, Advocate for the petitioners and Thiru.S.Thirumalaiappan, Public Prosecutor for the respondent and upon hearing the argument of both sides, this court made the following

ORDER

This petition has been filed by the petitioners u/s.483(1)(b) of BNSS for relaxation of condition imposed by this court in Cr.M.P.No.1472/2026 dated 29-05-2026.

Heard both side.

The learned counsel for the petitioners contended that the petitioners have complied with the condition imposed in Cr.M.P.No.1472 of 2026 dated 29.05.2026 from 03.06.2026 till date, and that the condition imposed on the petitioners is causing considerable hardship. It is further submitted that A1 is residing in Thiruvadanai,

while A2 and his parents are residing in Chennai. Hence, they prayed to modify the condition.

The learned P.P. conceded that the petitioners have obeyed the condition for a period of 3 days.

Considering the facts and circumstances of this case, and the fact that A1 is residing in Thiruvadanai and A2 along with his parents are residing in Chennai, this Court is inclined to modify the condition.

In the result, the condition imposed on the petitioners in Cr.M.P. No. 1472 of 2026, dated 29.05.2026, is modified as follows:

(i) The 1st petitioner/A1 is directed to appear and sign before the District Munsif-cum-Judicial Magistrate, Thiruvadanai, once in 15 days, i.e., on the 1st and 15th day of every English calendar month at 10.30 a.m., until further orders.

(ii) The 2nd petitioner/A2 is directed to appear and sign before the Vadapalani Police Station, Chennai, once in 15 days, i.e., on the 1st and 15th day of every English calendar month at 10.30 a.m., until further orders.
