He further submits that thought the cameras were installed by PWD, however, the maintenance work of the same is with BEL who in turn gives the said job to private Vendor namely Aurion Pro Solutions Ltd.

Ld. Addl. PP for the State has further submitted that Sh. Aashish Yadav from BEL is still working as informed by PW Sh. Raj Kumar who is present today and therefore, PW Sh. Aashish Yadav from BEL be called alongwith PW Sh. Asad Ansari from Aurion Pro Solutions Ltd. for the next date as both these witnesses are required to prove the certificate under Section 65B of IE Act and the CCTV footages, which were handed over to IO.

Ld. counsels appearing for the accused persons submit that they have no objection if the aforesaid witnesses are called.

In view of the submissions made above, PW Sh. Raj Kumar, Nodal Officer, BEL is discharged unexamined for today.

Let PW Sh. Aashish Yadav from BEL and PW Sh. Asad Ansari from Aurion Pro Solutions Ltd. be summoned, through IO, for the next date.

IO/Insp. Vijay Pal be also called for next date of hearing.

At this stage, accused Mustkeen and Asif submit that they do not have the capacity to engage a private counsel and they be provided a legal aid counsel.

Sh. Bhawan Singh, Id. LADC from the office of CLADC, who is attached with this Court as Remand Advocate, is appointed as legal aid counsel for accused Mustkeem and Asif in the present case.
