Perused the charge-sheet, cognizance order dated 20.05.2025, the police papers, the order dated 22.04.2026 framing charge and the entire case record. It appears that cognizance of the offences punishable under Sections 126(2), 115(2), 303(2), 76, 352, 351(2) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 was taken by this Court on 20.05.2025. Thereafter, charges were framed on 22.04.2026 and the case was fixed for prosecution evidence. On further scrutiny of the record, this Court finds that the accused persons have been charged with the offence punishable under Section 76 of the Bharatiya Nyaya Sanhita, 2023, which is exclusively triable by the Court of Sessions. Consequently, this Court has no jurisdiction to

Section 362 of the Bharatiya Nagarik Suraksha Sanhita, 2023 provides that if, at any stage of the inquiry or trial before signing the judgment, it appears to the Magistrate that the case ought to be tried by the Court of Sessions, the Magistrate shall commit the case to that Court. Accordingly, in exercise of the powers conferred under Section 362 of the Bharatiya Nagarik Suraksha Sanhita, 2023, <u>the case</u>, against the following accused persons:- 1.
