O R D E R

1. The instant transfer petition has been filed on behalf of the petitioner Manjur Shekh for transfer the case record bearing G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 which is still pending in the court of Id. CJM, Jamtara and its counter case ST. case No.87/2026, corresponding to Karmatanr P.S. Case No.57/2025 which is pending in this court for trial and disposal.

2. The case of the petitioner as narrated in the petition filed before this court, is that G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 which is pending in the court of Id. CJM, Jamtara and its counter blast case, ST. case No.87/2026, corresponding to Karmatanr P.S. Case No.57/2025, which is pending in the court of Ld. Principal Sessions Judge, Jamtara. Hence, he prayed to transfer G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 from the court of CJM, Jamtara to the court of Ld. Principal Sessions Judge, Jamtara for trial and disposal.

3. Heard the learned lawyer of the petitioner who submitted that G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 is pending in the court of Ld. CJM, Jamtara and its counter case ST. case No.87/2026, corresponding to Karmatanr P.S. Case No.57/2025 is pending in the court of Ld. Principal Sessions Judge, Jamtara. So, he prayed that for the ends of justice, the aforesaid case may be recalled from the court of CJM, Jamtara and transferred this case in the court of Ld. Principal Sessions Judge, Jamtara for trial and disposal.

4. Heard the Ld. Addl. P.P appearing on behalf of the state who opposed the submissions made by the learned lawyer of the petitioner and submitted that G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 is pending in the court of Ld. CJM, Jamtara and cognizance has been taken in this case on 05-02-2026 and at present it is fixed on 19-08-2026 for commitment and ST. case No.87/2026, corresponding to Karmatanr P.S. Case No.57/2025 is in the stage of evidence. So to avoid unnecessary delay of disposal of the case (ST 87/2026), the prayer of the ld. counsel of the petitioner may be rejected.

FINDINGS

5. After having heard the learned lawyer appearing on behalf of the petitioner as well as the Ld. Addl. P. P. appearing on behalf of the state, and as per the report of Sheristedar, I have gone through the facts and circumstances of the case and it transpires that G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 is pending in the court of Ld. CJM, Jamtara, and cognizance has been taken in this case on 05-02-2026 and at present it is fixed on 19-08-2026 for commitment and after commitment U/s 109 this record will sent to the Sessions court. ST. case No.87/2026, corresponding to Narayanpur P.S. Case No.57/2025 is pending in this court at the stage of evidence. It appears that the instant

transfer petition filed by the petitioner Kalpana Devi in view to delay in disposal of ST. case No.87/2026, corresponding to Karmatanr P.S. Case No.57/2025 pending in this court at evidence stage. As such, I am of the opinion that G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 pending in the court of Ld. CJM, Jamtara is not required to transfer in the court of Id. Principal Sessions Judge, Jamtara in the eye of the law.

6. Under these circumstances, the prayer for transfer of G.R. Case No. 77/2026, arising out of Karmatanr P.S. Case No.55 of 2025 from the court Ld. CJM, Jamtara to the court of Id. Principal Sessions Judge, Jamtara is hereby dismissed. Office is directed to send the copy of this order to the concerned court.
