This Application came up for final hearing before me on 20.07.2022 in the presence of Thiru. B. Kannan, Advocate for the Petitioners/Plaintiffs and Thiru. P. Jeyakumar, Advocate for the 1st, 4th, 5th Respondents and Government Pleader for 3rd Respondent and 2nd Respondent died and upon hearing the arguments on both side and upon perusing the records, having stood over till this date for my consideration, this Court passed the following

ORDER

1. This Application has been filed by the Petitioners/Plaintiffs Under Order 22 Rule 4 and Section 151 CPC to to implead 4th, 5th Respondents as 4th, 5th Defendants, the legal heirs of deceased 2nd Respondent/2nd Defendant.

2. Brief averments of Petition : -

On 06.06.2020 the 2nd Respondent/2nd Defendant died. Except 1st Respondent, 4th, 5th Respondents are also legal heirs of deceased 2nd Respondent. Hence, it is necessary to implead 4th, 5th Respondents as 4th, 5th Defendants, Hence, this application is to be allowed.

3. Brief averments of Counter of 1st, 4th, 5th Respondents :-

2nd Defendant Ramasamy died on 06.06.2020 and the death certificate of Ramasamy was obtained on 03.10.2020. Due to Covid-19 pandemic, the 1st Respondent was unable to file memo before this Court immediately and later during the normal course of court proceedings on 06.03.2021, the 1st Respondent/1st Defendant filed memo regarding the death of 2nd Defendant. The Petitioners failed to implead the legal heirs of deceased 2nd Defendant within the prescribed limitation period. They filed the impleading petition on 29.11.2021 only. The suit filed by the Petitioners/Plaintiffs is abated and they filed abatement petition in I.A.No.2/2021 and delay condonation petition in I.A.No.3/2021 without sufficient cause and reasonable grounds and filed this petition to implead the legal heirs of deceased 2nd Defendant. Hence, this application is to be dismissed.

4. The counsel for the 3rd Respondent/3rd Defendant endorsed in the application as 'no counter of R3'.

5. Point for consideration in this Application is whether this Petition is to be allowed or not?

6. Point:-

Heard both sides. Perused available records.

7. The Petitioners have filed this Application to implead 4th, 5th Respondents, the legal heirs of deceased 2nd Defendant as 4th, 5th Defendants. Eventhough, the 1st, 4th, 5th Respondents have vehemently opposed this application, they have not denied about the legal heirs of deceased 2nd Defendant. Hence, this court feels that a fair opportunity will be given to the Petitioners, since this is court of first instance. Hence to putforth both side case before this court to decide the suit on merit, this court grants opportunity to the Petitioners. Hence, this petition is allowed with condition.

8. In the result, this application is allowed with condition that the Petitioners shall pay a sum of Rs.500/- to the 1st, 4th, 5th Respondents by on or before 10.08.2022. Call on 10.08.2022.
