This appeal is preferred by the appellants/defendants 2 & 3 against the judgment and decree in O.S. No. 128/2016 of Subordinate Court, Aruppukottai, dated 05.12.2024.

The suit was filed for the relief of recovery of money on Pro-note directing the 1st defendant to pay a sum of Rs.5,14,800/- to the plaintiff with interest at the rate of 6% p.a. from the date of Plaint to till date of realization for the principal amount of Rs. 3,00,000/- to the plaintiff and since the 1st defendant

was died and the property belongs to the 1st defendant, which was attached as per the order in I.A. No. 403/2016, was inherited and enjoyed by his heirs namely the 2nd and 3rd defendants and direct the defendants 2 and 3 to pay the above amount failing which prays to auction the attached suit properties and pay the money from the auction sale amount and for costs.

Date of Presentation:	This appeal suit was originally presented before Hon'ble Principal District Judge, Virudhunagar District at Srivilliputtur on 13.02.2025 and taken on file as A.S. No. 69/2025 on 18.08.2025 (after sine returns) and made over to this Court on the same day as per the order of Hon'ble Principal District Judge, Srivilliputtur and case records received by this court on 26.08.2025 and proceeded as A.S. No. 69/2025.
Court Fee:	Value of the appeal suit - Rs.6,66,450/- For which, Court Fee Rs. 49,985/- paid under Section 22 and Section 52 of Tamilnadu Court Fees and Suit Valuation Act.

Appeal filed under Order 41 Rule 1 & 2 and Section 96 of C.P.C.

This appeal suit came up before me for final hearing on 03.06.2026 in the presence of Thiru. A. M. Vadivel, Learned advocate for the Appellants and Thiru.T. Perumalsamy and Thiru. A. Boanarkesh, Learned advocates for the respondent and upon considering all material records in this case and hearing the arguments in both sides and having stood over for consideration till this day, this court delivered the following

DECREE

1. That this appeal is dismissed.
2. That the judgment & decree in O.S. No. 128/2016 of Subordinate Court, Aruppukottai dated 05.12.2024 is

confirmed. .

3. That the appellants are directed to pay the cost of the appeal suit Rs. 7,130/- to appeal respondent.
