Order No.34 dated 07.08.2026

1. Today is fixed for production of the accused persons, hearing of the bail application dated 24.07.2026 filed on behalf of the accused Saokat Molla and written objection, if any, in the meantime, submission of report in respect of the petition dated 28.07.2026 filed on behalf of petitioner/Malek Ali Molla and hearing of the petition dated 28.07.2026.
2. Accused persons namely, Sujoy Mondal, Ahidul Islam Molla, Rahamat Ali Molla, Sainur Molla and Saokat Molla are produced virtually before this Court from J.C.
3. Ld. Special Public Prosecutor for NIA is present.
4. None turns up on behalf of the accused persons.
5. **Today Ld. Lawyers did not attend the Court proceedings due to resolution taken by the local Bar on account of death of a Ld. Advocate.**
6. Ld. Special Public Prosecutor of NIA files a petition praying for further judicial custody of the accused persons for the purpose of investigation.
7. Ld. Special Public Prosecutor of NIA files another petition along with three sealed envelopes containing particulars of Protected witness marked as “I”, “J” and “K” praying for declaring the witnesses as Protected witness nos. “I”, “J” and “K” u/s 17 of the N. I. A. Act, 2008 in the interest of justice.
8. One written objection has been filed against the bail application filed by accused Saokat Molla on behalf of the Prosecution/NIA.
9. One compliance report has been filed on behalf of the Prosecution/NIA in compliance with the order no.33 dated 28.07.2026 passed by this Court.
10. Another petition has been filed on behalf of the Prosecution/NIA praying for keeping on record the prosecution sanction, Expert opinion from CFSL & CERT-In and Exhibits as per list in the interest of justice.
11. One petition has been filed by the accused person namely Rahamat Ali Molla praying for a direction upon the concerned Correctional Home Authority to provide medical reports and documents to the family members of this accused person.
12. Let those be kept with the record.
13. In view of the Gazette Notification No. S.O. 4267 (E) dated New Delhi, the 31st July, 2026 and F No.11011/42/2022-NIA and in consultation with the Hon’ble Chief Justice of the High Court of Calcutta and the Government of West Bengal the **Special NIA (Exclusive) Court No.1 and Special NIA (Exclusive) Court No.2 have been designated as the Special Courts for the purpose of sub-section (1) of section 11 of the said Act, exclusively for the trial of the Scheduled Offences investigated by the National Investigation Agency and the power vested upon this Court in view of the Gazette Notification No. S.O. 3765**

(E) dated New Delhi, the 21st October, 2019 and F No.11011/06/2019-NIA (Part-1) for the trial of the Scheduled Offences investigated by the National Investigation Agency has been superseded.

14. Hence, the instant case record be transmitted to the designated **Special NIA (Exclusive) Court No.1 in the City Sessions Court Building, Kolkata for trial and disposal.**

15. Bench Clerk-I is directed to do the needful in this regard at once.

16. Fix **11.08.2026** for production of the accused persons from J.C. before the designated **Special NIA (Exclusive) Court No.1 in the City Sessions Court Building, Kolkata.**

17. The Superintendent of Presidency Correctional Home is directed to take necessary steps to ensure production of the above named accused persons before the designated **Special NIA (Exclusive) Court No.1 in the City Sessions Court Building, Kolkata** on the next date fixed.

18. Inform all concerned.

19. Accused persons be remanded to J/C till the date fixed i.e. 11.08.2026.

20. Let a copy of this order be sent to the NIA through the Ld. Special Public Prosecutor for information.

21. Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and compliance.
