**Bail Order**

First Bail Application no. **1028/2026** preferred by applicant/accused **Mohd. Lateef** is supported by an affidavit that no other application is pending nor has been disposed by any Court. The Court heard learned A.D.G.C. Criminal and the learned counsel of the applicant besides perusing the record.

Briefly it is the **Prosecution Version** that the complainant has a grocery shop in Katra, Sarai Mamrez, Prayagraj. On 05/01/2026 at 12:30 AM some unknown persons committed theft in his shop and stole goods from there. When complainant came to know about the incident he reached at his shop where he found items scattered, grocery items stolen and Rs. 4,500/- were stolen from the cash box. Whereafter this case was registered. On the other hand, it is the **Version of the Applicant/accused** that the applicant is a law-abiding citizen. The applicant has been falsely implicated in this case. The FIR is in unknown and there is no eye witness to the incident. Applicant has no criminal history and has not been held guilty by any Court. **Version of A.D.G.C Criminal** - Accused has committed the offense of this case. Therefore, the bail application of the accused should be dismissed by the Court. **Analysis of the Court** - ***1. The FIR is in unknown. 2. Applicant is not named in the FIR. 3. There is no eye witness to the incident. 4. There is no witness to the alleged recovery from the accuse. 5. Accused has not been convicted by any Court. 6. There is no criminal history of the accused. 7. Accused is in jail since 09-01-2026. 8. The offences are triable by the Court of Magistrate. 9. Earlier the bail application of the accused was dismissed by the Court of Magistrate. Therefore, without going into the merit of the case, bail application of the accused deserves to be allowed.***

**Order**

Bail application no. 1028/2026 preferred by applicant/accused **Mohd. Lateef** in Crime No.-06/2026, U/S- 331(4), 305(a), 317(2) BNS, P.S.- Sarai Memrez, Prayagraj is allowed. Applicant shall furnish Personal Bond of Rs. 50,000/- and 02 Sureties of the said same amount subject to the verification of the sureties and satisfaction of the lower Court.
