**Examination-in-chief:-**

My name is Sri Nikunja Tripura (aged 36 years), My father's name is Sri Sudhan Tripura. Currently I am residing at Jalefa, Lalchand Para. By profession I am day labour. I know the complainant Smt. Thanda Laxmi Tripura as she is my neighbour. On the day of the alleged incident I was not present at the PO and haven't witnessed anything through my eyes. I have heard from the local public that a commotion had broken out between Thanda Laxmi Tripura and Bakul Tripura, Smt. Chandpati Tripura and Smt. Sachin Mala Tripura. The commotion had broken out due to the dispute regarding a pond which belong to Sri Purna Tripura, husband of Smt. Thanda Laxmi Tripura. The witness has identified the all the accused person by name and face before this court.

**Cross-Examination:-**

The IO of this instant case has met me and has also enquired about this case. It is a fact that I share a good relationship with the family of Smt. Thanda laxmi Tripura. It is not a fact that the alleged incident occurred 18.08.2022. The witness stated that the alleged incident had occurred on 28 day of one month of the year 2022. It is not a fact that I did not hear from the local public that a commotion had broken out between Thanda Laxmi Tripura and Bakul Tripura, Smt. Chandpati Tripura and Smt. Sachin Mala Tripura and it is also not a fact that the commotion had broken out due to the dispute regarding a pond which belong to Sri Purna Tripura, husband of Smt. Thanda Laxmi Tripura. It is not a fact that the distance between my house and Smt. Thanda Laxmi Tripura house's is approximately one mile. It is not a fact that since I share a good relationship with the family of Smt. Thanda Laxmi Tripura I have deposed falsely before this court today.
