CHARGE

1- That on 13.11.2025, in the morning, in a agriculture field near village Oril Kevtana, within the limits of P.S. Pawai, District Azamgarh, you all, in furtherance of your common intention to kill, had beaten up to the complainant's son Narendra Bind with sticks, due to which he sustained grievous injuries and he died while he was taking to the hospital and thereby you all have committed an offence punishable under **Section 103 (1) B.N.S. read with Section 3(5) B.N.S.** and within the cognizance of this Court.

And I hereby direct that you all be tried by this Court on the said charge.

ORDER

Case called out. the accused **Suraj @ Mantu** is present and the accused persons **Neeraj Bind, Priyanka Bind, Shivshankar @ Shankar** is present under judicial custody.

Learned D.G.C. (Crl.) for prosecution opened its case by describing the charge brought against the accused persons and stating by what evidence he proposes to prove the guilt of the accused persons.

Learned counsel for the accused persons has submitted that no prima facie case has been made against accused person. There is no material against the accused persons.

Heard learned counsel for the parties and perused the record.

Upon consideration of the arguments of the learned counsels and perusal of the records, I am of the opinion that prima facie offence under sections 103(1), 3(5) B.N.S. is made out against the accused persons Neeraj Bind, Suraj @ Mantu, Priyanka Bind, Shivshankar @ Shankar at this stage and there is sufficient evidence collected by the prosecution to prove its case.

On the basis of the above facts and circumstances, I am of the view that charge for the offence under section 103(1), 3(5) B.N.S. to be framed against the accused persons.

Consequently, you all are being charged for the aforesaid offence. Put up on **15.04.2026** evidence. Summon the witnesses.
