Dayaram & Ors. Vs. State of U.P. & 1 Anr.

ORDER
23.03.2026

This transfer application has been moved on behalf of the applicants with the prayer to transfer both criminal revision in any one court on the ground that both criminal revisions have been filed against the same order dated 25.03.2025.

Learned counsel for the applicants is present and has submitted that the criminal revision no. 538/2025(Triveni Rajbhar & Anr. vs. State of U.P.) is pending in the court of Special Judge (EC Act), Azamgarh and the criminal revision no. 09/2025 (Dheeraj Rajbhar vs. State of U.P.) is pending in the court of A.S.J., Court No. 3, Azamgarh. Both the aforesaid criminal revisions have been filed against the same impugned order dated 25.03.2025, passed by the learned A.C.J.M., Court No. 13, Azamgarh. Therefore, both the aforesaid criminal revisions should be transferred to the same court for disposal as per law.

Learned D.G.C.(Crl.) is present and he has submitted that he has no objection if both the aforesaid revisions are transferred to any one court.

The Presiding Officers of the concerned courts have mentioned in their reports that the above mentioned criminal revisions are pending in their respective courts and there is no objection in transferring them to any other Court.

Heard learned counsel for the parties and perused the record as well as report of the Presiding Officers of the concerned Courts.

Upon perusal of the record and reports of the concerned Presiding Officers, it is found that the criminal revision no. 538/2025(Triveni Rajbhar & Anr. vs. State of U.P.) is pending in the court of Special Judge(EC Act), Azamgarh and the criminal revision no. 09/2025(Dheeraj Rajbhar vs. State of U.P.) is pending in the court of A.S.J., Court No. 3, Azamgarh.

Upon perusal of the record, it is found that the criminal revision no. 09/2025(Dheeraj Rajbhar vs. State of U.P.) and the criminal revision no. 538/2025(State of U.P. vs. Triveni Rajbhar) have been filed against the same

impugned order dated 25.03.2025, passed by the learned A.C.J.M., Court No. 13, Azamgarh and both the aforesaid criminal revisions are pending in two different courts. Therefore, in the interest of justice and to avoid two contradictory judgments, it is just and appropriate that both the aforesaid revisions should be transferred and disposed off by the same court. Hence, this transfer application deserves to be allowed.

ORDER

The transfer application is hereby allowed. The criminal revision no. 538/2025 (Triveni Rajbhar & Anr. vs. State of U.P.), pending in the court of Special Judge(EC Act), Azamgarh, is hereby withdrew and transferred to the court of A.S.J., Court No. 3, Azamgarh for hearing and disposal in accordance with law.
