JUDGMENT:

Today the case was fixed for consideration on the statements given by the parties in the Court. A perusal of the case file shows that on 5.11.2022, defendants no.1 and 2 have appeared in the Court and had given a

joint statement to the effect that they have entered into a compromise Ex.C1 with the plaintiff and that they have no objection if the suit of the plaintiff is decreed as per compromise Ex.C1. The plaintiff also gave a separate statement to the effect that suit be decreed as per compromise Ex.C1.

2. Keeping in view the statements given by the plaintiff, defendants, documents on record and in the interest of justice, the present suit is hereby decreed as per compromise Ex.C1. Compromise Ex.C1 be made a part of the decree. It is clarified that the parties to the suit shall not be entitled to lay claim over any specific portion of the suit property without getting it formally partitioned. This judgement, decree shall be subject to the laws of registration and shall not affect rights, title or interest of any person not a party to compromise Ex.C1 or not a party to the present suit. Decree sheet be prepared accordingly. File be consigned to the record room, after due compliance.
