CHARGE

I, **Jai Prakash Pandey**, Sessions Judge, Azamgarh, hereby charge all of you **Ramchandra Yadav @ Maiku, Amit Yadav, Sarfuddin, Vikas Yadav, Saurabh @ Kariya, Ramashish Yadav, Akash Yadav** and **Anil Yadav** as follows:

1- That on 29.03.2025, at about 11.15 PM, in Village Zameen Narhan, within the limits of P.S. Jiyanpur, District Azamgarh, you all have committed murder of complainant's son Ashwani Chauhan by beating with sticks, iron punch & iron rod and thereby you all have committed an offence punishable under **Section 103 (1) B.N.S. read with Section 190 B.N.S.** and within the cognizance of this Court.

2- That on the aforesaid date, time and place, you all entered into a criminal conspiracy with intent to commit murder of the complainant's son Ashwani Chauhan and thereby you all have committed an offence punishable under **Section 61(2) B.N.S.** and within the cognizance of this Court.

And I hereby direct that you all be tried by this Court on the said charge.

ORDER

Case called out. Accused persons namely **Amit Yadav, Vikas Yadav, Saurabh @ Kariya, Ramashish Yadav, Akash Yadav** and **Anil Yadav** are present. Accused person **Sarfuddin** is present from the District Jail, Azamgarh. Accused person **Ramchandra Yadav @ Maiku** appeared in the court through V.C. from the District Jail, Gorakhpur.

Learned D.G.C. (Crl.) for prosecution opened its case by describing the charge brought against the accused persons and stating by what evidence he proposes to prove the guilt of the accused persons.

Learned counsels for the accused persons has submitted that no prima facie case has been made against accused persons. There is no material against the accused persons.

Heard learned counsel for the parties and perused the record.

Upon consideration of the arguments of the learned counsels and perusal of the records, I am of the opinion that prima facie offence under section 103(1), 190, 61(2) B.N.S. is made out against the accused persons namely **Ramchandra Yadav @ Maiku, Amit Yadav, Sarfuddin, Vikas Yadav, Saurabh @ Kariya, Ramashish Yadav, Akash Yadav** and **Anil Yadav** at this stage and there is sufficient evidence collected by the prosecution to prove its case.

On the basis of the above facts and circumstances, I am of the view that charge for the offence under section 103(1), 190, 61(2) B.N.S. to be framed against the accused persons.

Consequently, you are being charged for the aforesaid offence. Put up on **09.02.2026** evidence. Summon the witnesses.
