Order

1. Vide this second application under Section 438 Cr.P.C. applicants-accused have sought pre-arrest bail in FIR No.25 dated 23.02.2022, under Sections 457,201 IPC, Police Station Sarhali. The first bail application under Section 438 Cr.P.C. filed on behalf of applicants-accused in the present FIR pertained to offence under Sections 454,380,427,34 IPC, under which the present FIR was initially registered. Vide order dated 15.03.2022, the said application under Section 438 Cr.P.C. was allowed. The present bail application under Section 438 Cr.P.C. has been necessitated on account of addition of offence under Sections 457,201 IPC, vide Rapat No.7 dated 25.02.2023 and applicants-accused apprehend their arrest in the same.
2. Vide order dated 04.01.2024, applicants-accused were directed to join the investigation.
3. Learned counsel for applicants-accused stated that applicants-accused have joined the investigation in furtherance of the interim order dated 04.01.2024, passed by this Court.
4. Separate statement of ASI Dilbag Singh, has been recorded in the Court to the effect that, applicants-accused, have joined the investigation on 14.01.2024, and they are not required for custodial interrogation.
5. In view of the statement of ASI Dilbag Singh, interim order dated 04.01.2024 is, hereby, made absolute. The applicants-accused shall abide by conditions incorporated in Section 438(2) of the Cr.P.C.

Accordingly, bail application stands disposed of. Papers be consigned to the record room.
