U.P. State Vs. Guddu @ Guddu Chaukidar.

Under Section-376, 506 IPC

PS-Pachpedwa

District-Balrampur

Case called out. Learned Special public prosecutor SC/St act present, none present for the accused Guddu @ Guddu Chaukidar.

From the perusal of record it reveals that the court has issued Non Bailable Warrant on 18.12.2025 against the accused Guddu @ Guddu Chaukidar on which SI Dilip Kumar Singh has reported that the concerned accused has died on 12.06.2025.

Witness C.W. 1 S.I. Dilip Kumar Singh in examination affirmed that he has gone for the service of the warrant issued by the court against the accused Guddu Chaukidar S/o Ganthe Kanaujiya R/o Ward No. 10 Marhi Mata, PS Pachpedva District Balrampur, the family members of the accused has informed that the accused Guddu Chaukidar has died on 12.06.2025 and produced a death certificate issued by Chairman of Nagar Panchayat, Pachpedva, District Balrampur. The report of SI Dilip Kumar Singh is Exhibited as Exhibit-1 and the photo copy of the death certificate as Exhibit -2.

C.W.- 2 Smt. Nibha Devi the complainant of the case in examination affirmed that she has lodged the case against the accused Guddu Chaukidar through 156(3) CrPC and has well knowledged that the concerned accused of the case Guddu Chaukidar has died one year ago.

C.W.-3 Ravi Kumar Verma in examination affirmed that currently, he is Chairman of Nagar Panchayat, Pachpedva, Balrampur and accused Guddu Chaukidar S/o Ganthe Kanaujiya resident of Ward No. 10 Marahi Mata, currently name Rameshwar Lohiya, Ward No. 12 Purani Bazar, Pachpedva, PS Pachpedva District Balrampur has died on 12.06.2025 and he has issued death certificate of the said accused with his signature and seal.

Since accused Guddu @ Guddu Chaukidar has been passed away on 12.06.2025. Hence, there is no justification to proceed with against accused Guddu @ Guddu Chaukidar (now dead). Sureties of accused Guddu @ Guddu Chaukidar are also liable to be discharged.

ORDER

This Sessions Trial No. 158/2023 (Sessions trial Computer No. 284/2023) under Section 376,506 IPC PS Pachpedwa, District Balrampur against accused Guddu @ Guddu Chaukidar is **abated**. Sureties to the accused stands discharged. Since the deceased Guddu @ Guddu Chaukidar is the only accused of the case so
