Examination-in-chief resumed on S.A. by Advocate Ms Swati Bhajipale, holding for Shri P.S. Mirache, learned Advocate for the petitioner

I am attached to Neuron Hospital since 8/12/2015 as administrator. I have brought it with me. I have been authorised to appear before the court vide authority letter signed by Dr. Pramod Giri, Director of Hospital. Authority letter is correct, marked as **Exh. 39.**

2] I have also produced copy of final bills issued by hospital. Said bill is signed by Surekha Kanekar, billing clerk, attached to hospital. Patient namely Kajal Potwar, was admitted in hospital on 5/6/22 and discharged on 21/6/22. Hospital charged Rs. 1,41,840/-. Discount of Rs 16,540/- was given and hospital received Rs. 1,25,000/-. Contents of the bill produced by me is correct, hospital received the said amount, marked as **Exh. 40.**

3] Now I am referred with bill from court record. It is correct as per the bill produced by me. Bill on court record is marked as **Exh. 40/A.**

4] Now I am referred with second final bill produced by me, which was issued on 5/8/22. Patient was again admitted on 16/7/22 and discharged on 5/8/22. Hospital charged Rs 3,26,490/-. Discount of amount Rs. 50,000/- was given. Hospital received Rs. 2,76,490/-. Bill is signed by Surekha Khanekar, it is correct, hospital received said amount, bill is marked as **Exh. 41**.

5] Now I am referred with similar summary bill produced on record. It is correct, marked as **Exh. 41/A**.

6] Now I am referred with third final bill produced by me, which was issued on 20/09/22. Patient was again admitted on 13/09/22 and discharged on 20/0922. Hospital charged Rs 68,450/-. Discount of amount Rs. 6,450/- was given. Hospital received Rs. 62,000/-. Bill is signed by Surekha Khanekar, it is correct, hospital received said amount, bill is marked as **Exh. 42**.

7] Now I am referred with similar summary bill produced on record. It is correct, marked as **Exh. 42/A**.

Cross-examination by Shri Mayur Pradhan, learned Advocate for respondent No. 1 :

8] Those bills includes the amount in respect of investigation done in the hospital. The amount of receipts annexed with those bills is included in final bill. Some discount was given to patient. Hospital received the amount as deposed by me. There was

no refund under any scheme of State Government to the patient. Some amount was paid online, debit card, credit card and some in cash. I have not brought with me account statement of the bank for receiving payment online. I have not brought cash memo. Witness volunteers that some receipts are produced on record by petitioner. It is not correct to say that no amount has been received by hospital.

Cross-examination for respondent No. 2 :

9] Respondent No. 2 proceeded ex parte, hence, no cross.
