CHARGE

I, Shashwata Pandey, Additional Sessions Judge/Special Judge (E.C. Act), Court No. 04, Deoria, hereby charge you accused persons namely Mannu Yadav & Shailendra Singh @ Tiger as follows:

That, on 06.04.2019 during the search to the arrest of the accused Mannu Yadav in relation to the Case Crime No. 100/19 U/s 302, 506 IPC and 7 CLA, you the accused persons were stopped by the Police Officials near *Nakta Puliya*, you the accused persons fired at Police Officials with the common intention, knowledge and under such circumstances that if by firing at the Police Officials, you had caused their death, you would have been guilty of murder. You the accused persons namely Mannu Yadav & Shailendra Singh @ Tiger by the said act have committed attempt to murder, punishable under Section 307/34 of the Indian Penal Code, and within the cognizance of this Court.

And I hereby direct that you accused persons namely Mannu Yadav & Shailendra Singh @ Tiger be tried by this Court on the said charges.
