ORDER

Heard on the bail application, filed by applicant **Gurmeet Singh** for the grant of anticipatory bail in the above said FIR No. 55 dated 30.03.2025, under Sections 115(2), 118(1), 126(2), 140(3), 304, 351(2), 191(3), 190, 61(2) of BNS 2023, Police Station, Amlah.

2. Learned counsel for the applicant has argued that the FIR has been registered against Sunny and others and name of the applicant has not been mentioned in the said FIR. The applicant had contested the

election of Sarpanch of village Mudhrian against Bittu Ram. The complainant is party man of Bittu Ram and due to party friction, Bittu Ram Sarpanch is having grudge towards the applicant. Earlier, a cross FIR No. 152 dated 03.11.2024, under Sections 115(2), 126(2), 331(6), 191(3), 190, 324(4), 351(3) of BNS, P.S. Amloh was registered against the applicant and others and said Bittu Ram and others wherein compromise took place and the applicant and others were granted bail. The police is raiding house of the applicant. Hence, he prayed for anticipatory bail.

3. On the other hand, learned Addl. PP for the State has contested the bail application on the ground that the accused-applicant is involved in heinous crime and has prayed for dismissal of the bail application for anticipatory bail.

4. FIR was registered on the statement of Navdeep Kumar to the effect that he was doing the work of AC repair. On 29.03.2025, he and Vishavjit Singh alongwith Taran Kumar were going on their motorcycle bearing no. PB48G-3977 make Hero to repair the AC of Bittu Sarpanch. When they were coming back after repairing the AC on the above said motorcycle to Amloh and when they reached near the bridge of Village Anniyan, at about 09:00 pm, one car make Creta of white colour came from the side of Amloh and the driver of the said vehicle hit the motorcycle. All the three riders of the motorcycle fell on the road. The Creta car was bearing no. 7986. On the driver side, Sunny was sitting who was carrying one naked kirpan and he alighted from the car. Beside him,

Cheema was sitting who also alighted from the car and he was armed with Khanda. On the rear seat of the car, Avtar, Manjoban Sandhu, Ravi and one un known person who had covered his face with hanky were sitting. Out of them, Avtar was armed with baseball and other person was armed with a stick. Sunny gave a blow with kirpan which hit his left side. Cheema gave a blow with khanda which hit his right arm/wrist. When he tried to run away, Avtar gave a baseball blow on his head. All the accused persons gave the blows with their respective weapons on his body. Karan Kumar accompanying was also given a blow on his head by Avtar Singh with baseball. It hit backside of head of Karan Kumar on the left side and Cheema gave a blow with Khanda to his friend Karan Kumar which hit on his right leg. On left leg of Karan Kumar, Avtar Singh gave blow with baseball. The above said persons gave blow with baseball on the head of Vishavjit Singh @ Dishu. In the meantime, three motorcycles came at the spot which were being ridden by two persons each. Out of them, two persons were recognized by his friend Karan Kumar who were Sabar and Hakam, son of maternal aunt of Cheema Sabar gave fist blows to Karan Kumar and snatched mobile phone of 16 pro of golden colour from the right pocket of the pants worn by him. Thereafter, all the above said accused persons picked them forcibly and threw them in their car, kidnapped them and took them to some abandon place at a motor in village Badinpur and gave beatings to them. Thereafter, Sunny and Cheema asked them to remove their clothes and forcibly made them to

drink liquor. Ravi prepared their video. Thereafter, all the above said accused persons by threatening to kill went away along with their respective weapons. Root cause of the incident was that 4-5 months ago Garibu and Laddi alongwith 50-60 persons gave them beatings after stopping their Breeza car and Laddi and Ravi had prepared their video of beating them. The said video was made viral and due to this they have exchanged words with Ravi. They were given beatings at the instance of Laddi Mullanpur.

5. ASI Budh Singh has appeared and stated that that as per version of the complainant and as per FIR, there is one un known person who has not been traced out till now and investigation is pending before him.

6. From the entire perusal of the file, though the name of Gurmeet Singh is not cropped upon but one un known person has been stated by the complainant. In this view of matter, applicant Gurmeet Singh is ordered to be released on interim anticipatory bail and the applicant is directed to join investigation and in the event of his arrest, he is ordered to be released on interim anticipatory bail on his furnishing bail bonds to the satisfaction of Investigating Officer, subject to the following conditions:-

- A. That accused-applicant shall not hamper the trial;
- B. That accused-applicant will not try to prevail upon the witnesses;
- C. That accused-applicant will appear in the court

on each and every date;

- D. That accused-applicant will not leave the country with out prior permission of the court.
