COMMITTAL ORDER

The accused above-named has been sent by the SHO of Police Station, Rania to face trial for offence under Sections 363 and 366-A of The Indian Penal Code.

2. In brief, the facts of the present case are that the present case was registered on the complaint dated 12.09.2021 moved by the complainant Laxman Singh, who alleged that he has two daughters and two sons. His daughter i.e. the victim is aged about 16 years. On the intervening night of 11/12.09.2021, the victim went from the house without telling anybody. Her date of birth is 08.02.2006. He suspected that his relative Gurpreet Singh had enticed away the victim on the pretext of marrying her. Legal action be taken against the accused.

3. On 13.09.2021, the investigation was undertaken by DySP, Ellenabad. On 31.10.2021, the victim was produced by her parents. A recovery memo was prepared and the statement of the victim under Section 164 Cr.P.C. was got recorded. Further investigation was undertaken by ASI Kiranpal Kaur. On 01.11.2022, counselling of the victim was got done. The victim was handed over to her parents. On 11.08.2022, the accused Gurpreet Singh was arrested by ASI Rajinder Parsad. He got recorded his disclosure statement. An identification memo and site plan were prepared. After completion of the usual formalities of investigation, the challan was filed in the Court against the accused.

4. In compliance of Section 207 Cr.P.C., copies of report and all the relevant documents were supplied to the accused free of costs, which have been found complete by the accused in every respect.

5. I have heard Learned APP and the Learned counsel for the accused and with their help, the record of the case has also been perused very carefully.

6. Since the offence under Section 366-A of The Indian Penal Code is exclusively triable by the Learned Court of Sessions, so the present case is hereby committed to the Learned Court of Sessions at Sirsa.

7. The commitment of the present case stands notified to the State as the order was dictated and pronounced in the presence of Learned APP.

8. The accused Gurpreet Singh, who is on bail, is directed to appear before the Court of Learned Sessions Judge, Sirsa on 30.11.2022 at 10:00 am sharp. The Reader of the Court is directed to prepare necessary Kalandra and Ahlmad concerned is directed to send the case file to the Court of

Learned Sessions Judge, complete in all respects, well within time.
