COMMITMENT ORDER.

1. S.H.O. Police Station Lambi has sent up the accused as described in detail here in above to face the trial under sections 363,366-A IPC.
2. Brief facts of the case are that on 13.07.2020, ASI Gurmeet Singh along with other police officials in connection with patrolling was present at Bus stand Baloch Kera when Gurbachan Singh son of Bhagwan Singh along with Jasvir Singh son of Rulia Ram, R/o Bhai Ka Kera, met IO and Gurbachan Singh got recorded his separate statement to the effect that he is the resident of above said address and works as labourer; that he has four children and out of which two girls are elder and two sons are

younger; that his eldest daughter namely Chimna Kaur, aged about 15 years studied up to 2-3 standard from Government Primary School, Mahmood Khera; that on 30.06.2020, he along with his family went to plant paddy in the field of Sukhwant Singh son of Baltej Singh, R/o Bhai Ka Kera and left his eldest daughter Chiman Kaur alone to watch the house; that as he was not feeling well so he returned to his house at about 11:00 Am, when he saw a motorcycle coming from the side of his house which was being driven by Paramjit Singh son of Bhagat Ram and his daughter Chimna Kaur was sitting at the back of the motorcycle; that he tried to stop them but they did not stop; that her daughter Chiman Kaur eloped with Paramjit Singh son of Bhagat Ram R/o village Bhai Ka Kera on his false promise of marrying her; that they tried their best to search Chimna Kaur but in vain. On the basis of this statement, FIR under sections Under Sections 363, 366-A, IPC was registered in which investigation was initiated. Place of occurrence was visited during investigation and site plan was prepared. Accused was arrested. Victim Chimna Kaur was recovered. Statement of witnesses under section 161 Cr.P.C were recorded. Statement of victim Chimna Kaur under section 164 Cr.P.C was got recorded.

3 After completion of other necessary formalities of the investigation, challan under sections 363, 366-A IPC was prepared and presented against the accused in the court.

4. Upon presentation of challan in the court, copies were supplied to the accused as required under section 207 of Cr.P.C.

5. From the scrutiny of papers, prima facie case under sections 363, 366-A are found to have been made out against the accused. The offence u/s 366-A IPC is exclusively triable by the Ld. court of Session. Hence, the present case is committed to the court of Ld. Sessions Judge, Sri Muktsar Sahib for 11.06.2021. Accused Paramjit Singh is directed to appear before the court of Learned District & Sessions Judge, Sri Muktsar Sahib on 11.06.2021 at 10:00 A.M. sharp. Ahlmad is directed to send the file complete in all respect, to the court of Ld. Sessions Judge, Sri Muktsar Sahib well before the date fixed. Intimation regarding the commitment of the case be given to the Public Prosecutor.
