This bail application has been filed by the accused/applicant Noor Alam involved in Case Crime No. 136/2025 under Sections 109(1), 3(5) BNS, P.S. Meerganj, District Jaunpur.

The prosecution story in brief is that complainant SHO Vinod Kumar Anchal lodged an FIR at P.S Meerganj, Jaunpur alleging therein that on 15.10.2025, he along with other police officials was on patrolling duty and present at Chauki Kala Highway Tirha. After sometime they saw a pick up bearing No. UP62AG0408 coming from Bandhva side, when the police officials indicated to stop, the driver fasten the vehicle. When the police officials followed them, they thrown brick and stone on the police officials. They started firing on police officials as a result of which a bullet hit on his bulletproof jacket. In self defence, he also fired on them as a result of which two accused sustained firearm injury. They admitted their offences and told their name Asif @ Bunel @ Saleem and Kavinash @ Kariya, they told the name of their companions as, Muddasir, Vishal Banvasi, Baba Banvasi @ Ramsingh, Arif and Sujeet @ Pagal and admitted their offence. two country made pistol, 04 cartridges, one pick-up, and 30,000/- have been recovered from their possession named Asif @ Bunel @ Saleem, Kavinash @ Kariya, Muddasir and Noor Alam.

Heard learned counsel for the applicant and learned DGC criminal for the state and perused the materials available on record.

Learned counsel for the applicant has contended that the applicant is innocent and he has not committed any offence. There is no independent witness of the alleged incident. There is no recovery from his possession. The alleged recovery is false and fabricated. The FIR version is totally false and fabricated. He has no connection with the alleged incident. On the above grounds, it is prayed that the accused/applicants be released on bail.

Learned DGC (Crl) has opposed the bail application and alleged that the accused along with other co-accused shot fire on police officials with intention to caused death.

Learned counsel for the defence denied the allegations against accused/applicant and alleged the the said recovery is false and fabricated. The alleged recovery is true or false is the matter of evidence. Allegation of shooting fire on police officials with intention to cause death has been levelled against accused/applicant but none of the police officials have sustained any injury in the occurrence. The accused/applicant is languishing in jail since 15.10.2025. Co-accused Avinash and Asif have already been enlarged on bail by this court.

Considering the facts and circumstances of the case, ground of parity, without expressing any opinion on the merits of the case, bail application deserves to be allowed.

Order

Application for bail of accused/applicant Noor Alam, in Crime No. 136/2025, P.S. Meerganj, Jaunpur is allowed. Applicants be released on bail on furnishing a personal bond of Rs. 50,000/- (Fifty thousand) and two reliable sureties each in the like amount subject to satisfaction of the court concerned.
