This bail application has been filed by the accused/applicant Subhanshu Singh @ Sudhanshu, involved in Case Crime No. 94/2026, under Section 103(1), 3(5) BNS, P.S. Line Bazar, District Jaunpur.

The prosecution story in brief is that complainant Rajan Yadav lodged an FIR at P.S Line Bazar, Jaunpur alleging therein that on 04.03.2026 at about 06:30 PM, in front of Electricity Office, his father's scooty dented a car bearing no. UK07 BK4724. On that issue, Sashwat Singh and his friend started beating his father, pressed his neck by his foot as a result of which his father died.

Heard learned counsel for the applicant and learned D.G.C. (Crl.) for the state and perused the materials available on record.

Learned counsel for the applicant has contended that the applicant is innocent and he has been falsely implicated in this case due with malafide intention. There is delay in lodging the FIR. At the time of FIR, only person was named, during investigation name other accused/applicant included. He has no connection with the alleged incident. The complainant is not a witness of the alleged incident. He has no criminal history. On the above grounds, it is prayed that the accused/applicant be released on bail.

Learned D.G.C. (Crl.) has opposed the bail of the accused/applicant and alleged that he along with other co-accused assaulted the father of complainant and committed murder.

In FIR, serious allegation of committing murder has been levelled against Sashwat Singh and his companions. The complainant has supported the FIR version in his statement recorded under section 180 BNSS. As per mortem report, 3 injuries has been found on the body of deceased in the form of contused swelling on head (parietal bone fractured), abrasion on elbow joint and multiple bruse blue in color. Cause of death is mentioned as hemorrhage shock and coma as a result of ante-mortem head injury. A perusal of record transpires that the incident has occurred at evening 06:30 PM in city. I.O. has collected other oral evidences against the accused/applicant which lends credence to the prosecution story. Charge sheet has been submitted after investigation of the case. Bail application of co-accused Shaswat Singh and Devansh Singh have already been rejected by this court. Allegation against the accused is serious in nature.

Considering the facts and circumstances of the case, nature and gravity of offence and materials available on record, the bail application is liable to be rejected.

Order

Application for bail of accused/applicant Shubhansu Singh @ Sudhanshu, involved in Case Crime No. 94/2026, P.S. Line Bazar, District Jaunpur is rejected.
