ORDER

1. Vide this order, four bail applications under Section 439 Cr.P.C, one on behalf of accused-applicant Adarsh, second on behalf of accused-applicant Rohit Kumar, third on behalf of accused- applicant Abhishek Singh and fourth on behalf of accused- applicant Ramit Kumar, in FIR no.138 dated 18.10.2019, under Section 21 of NDPS Act, P.S. Shambu, shall be disposed of.

2. Record of investigation produced and perused.
3. Brief facts, relevant for disposal of present bail applications are that recovery of 220 gram Heroin from dash board of car bearing no. PB 07BT 2078, in which all accused-applicants were travelling, is alleged to have been effected, on 18.10.2019.
4. The alleged recovery falls in non-commercial quantity. The presentation of challan and conclusion of trial shall take time. In these circumstances, the accused-applicants are ordered to be released on bail on furnishing bail bonds in the sum of Rs. one lac each with one surety each in the like amount, subject to the following conditions:
 1. That the accused shall not tamper with prosecution evidence;
 2. That the accused shall not leave the country without prior permission of the Court;
 3. That the accused shall appear in the court on each and every date hearing.
5. Bail applications thus stands allowed accordingly. Attested copy of order be placed in connected bail applications. Papers be attached with the remand papers/trial file.
