JUDGMENT

Accused is voluntarily admitted guilt of offence. Therefore, the accused is liable to be convicted. Accused is submits that he is poor person and sole earning member of his family. Therefore, accused prayed for leniency. Considering submissions of the accused, in my view, lenient view will have to be taken, while imposing sentence. Hence, I pass the order :-

ORDER

1. The accused is convicted under section 252 of Code Criminal Procedure for the offence punishable under section 279 and section 336 of Indian Penal Code .

2. The accused shall pay fine of Rs. 1,000/- (One Thousand only) and in default to suffer 1 month simple imprisonment for offence punishable Under Section 279 of IPC.

3. The accused shall pay fine of Rs. 250/- (Two Hundred Fifty only) and in default to suffer 07 days simple imprisonment for offence punishable under Section 336 of IPC.

4. Copy be provided to the accused free of cost.
