CHARGE

I, **Kuldeep Saxena, Sessions Judge, Sitapur** hereby charge you **Baijnath, Anil and Vishal** and as follows:-

Firstly, that on 23.12.2021 at 06.00 p.m., in furtherance of your common intention, you voluntarily caused harm to the complainant's son Amit by assaulting him with sharp edged weapon. In this way, you people committed such an act which is punishable under Section 323/34 of the IPC and is within the cognizance of this Court.

Secondly, that on the abovementioned date, time and place you all, in accordance with your common intention had assaulted the complainant's son Amit with sharp edged weapons. Thus, you all have committed a crime which is punishable under Section 324/34 of the Indian Penal Code, and within the cognizance of this Court.

Thirdly, that on the abovementioned date, time and place, you people abused the complainant's son Amit, due to which there was a possibility of disturbance of public peace. In this way, you people committed an act which is punishable u/s 504 I.P.C.

Fourthly, that on the abovementioned date, time and place, you people repeatedly intimidated Amit by threatening to kill him. Thus, you committed an act which is punishable u/s 506 of the I.P.C. and is within the cognizance of this Court.

Lastly, that you all, on the abovementioned date, time and place, and, in furtherance of your common intention, kicked and punched and assaulted Amit with a sharp edged weapon with such intention and under such circumstances, that if by that act you had caused the death of Amit, you would have been guilty of culpable homicide not amounting to murder and thereby committed

an offence punishable under section 308/34 I.P.C. and within the cognizance of this court.

I hereby direct that you all be tried by this Court on the said charge.

After hearing the arguments of both the parties and after perusing the file and case diary, prima facie, sufficient evidence is available for charging the accused persons under Sections 323, 324, 308, 504 and 506 I.P.C. Hence, the accused persons should be charged accordingly.

Charge was framed against the accused persons as above. The accused persons denied the allegations and demanded a trial.
