CHARGE

I, **Kuldeep Saxena, Sessions Judge, Sitapur** hereby charge you **Lakhan** as follows:-

Firstly, that you, on 18.11.2004 at 03.00 a.m., with such intention and under such circumstances, you fired at complainant's brother Ranjeet with katta with the intention of killing him and if by that act you had caused the death of Ranjeet, you would have been guilty of murder, and thereby committed an offence punishable under Section 307 I.P.C. and within the cognizance of this court.

Secondly, that you along with your associates, on the abovementioned date and time, in the house of complainant situated at village Belhaiya, within the local limits of P.S. Mishrikh, District Sitapur, committed house trespass by entering into the house of the complainant, having made preparation for causing hurt to the complainant and that you thereby committed an offence punishable under Section 452 I.P.C. and within the cognizance of this court.

Thirdly, that you along with your associates, on the said date, time and place, intentionally abused and thereby provoked complainant with the intention that such provocation will cause the said person to break the public peace and thereby committed an offence punishable under section 504 I.P.C. and within the cognizance of this court.

Lastly, that you along with others, on the said date, time and place, committed criminal intimidation by threatening the complainant to kill and thereby committed an offence punishable under Section 506 I.P.C. and within the cognizance of this court.

I hereby direct that you all be tried by this Court on the said charges.

File is presented. Accused person **Lakhan** is present in judicial custody.

Charge-sheet has been submitted against the accused person under Sections 307, 452, 504 and 506 I.P.C. On behalf of the prosecution, the learned D.G.C. Criminal, while starting the case, drew attention towards the evidence available on record and submitted the details of the proposed evidence, which would prove the allegations against the accused person.

After hearing the arguments of both the parties and after perusing the file and case diary, prima facie, sufficient evidence is available for charging the accused person under Sections 307, 452, 504 and 506 I.P.C. Hence, the accused person should be charged accordingly.

Charge was framed against the accused person as above. The accused person denied the allegations and demanded a trial.
