**COMMITMENT ORDER**

1. The accused Lovepreet Singh alias Bhupa was forwarded to  
this Court by the SHO of P.S.City Nakodar for facing trial for the  
commission of offences punishable under Section 379-B, 427  
IPC,offences added later on u/s 411, 397 IPC in FIR No.115 dated  
20.10.2022.

2. Factual matrix of the prosecution case is that present case  
was registered on the statement of complainant Gurmail Singh son of  
Amar Singh, resident of Village Chak Khurrd, PS Sadar Nakodar got

recorded with ASI Ranjit Singh, wherein he stated that he is agriculturist by profession. On 17.10.2022, he went to Village Malsian PS Shahkot to meet his relatives, on his Aactiva No.PB-08-DC-2392. When at about 3.30 p.m. he was returning to his village and reached opposite Sandhu Zimidar Dhaba Nakodar, Main Highways, two persons came behind him on platina motorcycle. The pillion rider of the motorcycle was armed with datar, they came parallel to his Aactiva they asked him to stop on the point of datar. He in order to save himself tried to ran away but the said persons gave leg blow on his Aactiva and had thrown the Aactiva. Both the said persons came down from the motorcycle and they took Rs.4800/- from the pocket of his short by showing datar. On raising raula by him, the said persons ran away from the spot alongwith datar on their motorcycle. Due to fall, he sustained injuries on his left leg and ankle and his Aactiva also got damaged. The passerby after arranging a vehicle got him admitted in Civil Hospital Nakodar from where he was referred to Civil Hospital, Jalandhar. Due to his critical condition, his family got him admitted in Orthonova Hospital, Jalandhar. He and his family could not intimate the police in this regard due to trouble. He and his family came to know that the persons who committed the said incident were Lovepreet Singh alias Bhupa son of Mangal Singh, resident of Mullewal Khehra, PS Shahkot and Honey resident of Kotli Gajran PS Shahkot, District Jalandhar and the motorcycle bearing no.PB-08-CJ-0556. On the basis of the statement of the complainant investigation was initiated. Accused Harmanpreet alias Honey son of Lachhman Singh, resident of Kotli Gajran, PS Shahkot

could not arrested despite raids at his house on different dates. He has absconded to avoid his arrest. His supplementary challan will be presented after his arrest. After completion of investigation, challan against the accused Lovepreet Singh alias Bhupa was presented in the court.

3. Copies of documents of challan has been supplied to the accused in compliance of Section 208 of Cr.P.C. free of cost against the statement of accused recorded separately.

4. From the scrutiny of challan/report under Section 173 of Cr.P.C. and documents attached, prima facie case under Section 379-B, 427 IPC, offences added later on u/s 411, 397 IPC is found to have been made out against the accused, out of which offences under Section 379-B, 397 IPC are exclusively triable by the Learned Court of Session, therefore, the present case is committed to the Court of Learned Sessions Judge, Jalandhar for 22.02.2023. The accused Lovepreet Singh alias Bhupa being in custody, the jail authorities are directed to produce him before the Court of learned Sessions Judge, Jalandhar on the date fixed at 10.00 a.m. sharp. APP be notified about the commitment of the case and the case file complete in all respects is ordered to be sent to the court of Ld. Sessions Judge, Jalandhar, well before 22.02.2023.
