STATE V/S MUNNU DIXIT @ GURU NARAYAN

Case called out. The file is fixed for appearance.

On perusal of the file it is evident that in the present case of S.S.T. No:- 82/2008 State V/s Munnu Dixit @ Guru Narayan filed in Case Crime No:- 261/2006 under Sections:- 323, 504, 506 I.P.C. & 3(1)X S.C./S.T. Act of Police Station:- Bighapur, District:- Unnao, the only accused Munnu Dixit @ Guru Narayan S/o:- Balkrishna Dixit R/o:- Mahai, Police Station:- Bighapur, District:- Unnao has been absent since various dates in the court. N.B.W. was issued against him by the court in order to ensure his presence. The N.B.W. issued by the court is returned with the endorsement that the when sub-inspector Mohit Kannojiya went to his house searching him then the members of his family told him that accused Munnu Dixit @ Guru Narayan S/o:- Balkrishna Dixit has died on 14.12.2022 in a road accident. The family members have provided him a copy of his death certificate, which is annexed with the report.

The aforesaid case is at the stage of appearance in which C.W.-1 Satyaveer Kumar has given his statement on oath that “When the warrant which was issued by the court against accused Munnu Dixit @ Guru Narayan S/o:- Balkrishna Dixit R/o:- Mahai, Police Station:- Bighapur, District:- Unnao was processed by Sub-Inspector Mohit Kannojiya, who was posted at the police station then it was found that the above mentioned accused Munnu Dixit @ Guru Narayan S/o:- Balkrishna Dixit has passed away on 14.12.2022, for which a written report has been given by the aforesaid Sub-Inspector and a copy of death certificate issued by Uttar Pradesh Government has also been presented along with the report by which the death of accused Munnu Dixit is being confirmed. He is aware of the handwriting and signature of above mentioned Sub-Inspector.”

Therefore, in the light of the above and on the basis of the police report and death certificate received it has been established that the only accused Munnu Dixit @ Guru Narayan has died on 14.12.2022 in a road accident. On the perusal of

the file it is evident that there was only one accused Munnu Dixit @ Guru Narayan in the case.

Accordingly, as the sole named accused in the file was Munnu Dixit @ Guru Narayan, whose death has now resulted in no further legal proceedings pendency in the aforesaid case. Hence, the case against the accused Munnu Dixit @ Guru Narayan is liable to be abated.

ORDER

The said case and proceedings pending against the accused Munnu Dixit @ Guru Narayan is hereby **abated**. Records to be consigned accordingly as per procedure.
