One application seeking exemption from personal
appearance has been filed on behalf of accused no. 4, Surjit
Lal by Ld. Counsel.

Heard. It is submitted on behalf of accused that
accused has no objection if the witness is examined and he

will not dispute his identity during such examination of witnesses.

For the reasons stated in the application and submissions made by Ld. Counsel, the application is considered and is allowed for today only.

PW-28 ASP R.S.Solanki is present for his further cross-examination. He is partly cross-examined by Ld. Counsel for accused no. 2 & 4 for about one and half hour. Ld. Counsel for accused nos. 2 & 4 has sought adjournment for conducting remaining cross-examination of PW-28 on the ground that he has to catch an international flight. The request for adjournment is strongly opposed by Ld. SPP and the witness/PW-28. Ld. Counsel for accused nos. 2 & 4 has submitted that he is seeking adjournment under compelling circumstances and he has already filed the application dated 05.08.2026 in this regard.

In these circumstances, in the interest of justice, the further cross-examination of witness/PW-28 is deferred and the witness is discharged for today. The application dated 05.08.2026 filed on behalf of accused nos. 2 & 4 stands disposed off accordingly. Summons be send to said witness for next date of hearing.

One application is filed on behalf of CBI for returning of unrelid documents. Let copy of the application

be supplied to all the accused persons/Ld. Counsels for accused persons. This application shall be considered on the next date of hearing.

In view of above, matter is now adjourned for further cross-examination of PW-28 ASP R.S.Solanki on behalf of accused no. 2 and 4 and remaining accused for **08.09.2026 and 09.09.2026.**
