SUIT CLAIM: The Suit was filed on **09/11/2017** by the plaintiff
and prays the following relief:

Rs. 2,03,37,990/- Principal due amount as para 9 of the suit.

Rs.1,65,95,000/- Paid by the defendants to Plaintiff till 2015.

Rs.2,00,000/- Paid by the defendant no. 4 on 06.09.2017.

Rs. 35,42,990/- Balance Payable

That a decree for the said amount along with costs of the suit and interest @ 18% from the date when the amount became due i.e. December, 2015 till realisation recoverable from the property and the person of the defendants be passed in favour of the plaintiff and the defendants.

- B. That the costs of the suit be awarded.
- C. That such other relief as may be deemed just and proper be given.

This suit coming on this day for final disposal before **Sri I.P.Naik, LXIII Additional City Civil & Sessions Judge, Bengaluru City**, in the presence of Sri Kapil Dixit - Advocate for the Plaintiff and of Sri N.Thimmegowda, Advocate for the defendants No.1, 3 to 5. Defendant No.2-Dead.

It is ordered and decreed that suit of the plaintiff is hereby decreed with costs.

It is further ordered and decreed that the Defendant No.1 and its Trustees are hereby directed to pay the amount of Rs. 35,42,990/- with interest at the rate of 6% p.a. from the date of the suit till realisation of entire amount.

And that a sum of **Rs.1,64,010/-** be paid by the Defendant/s to the Plaintiff/s on account of the costs of this suit.
