as follows -

Firstly, You all on 14.03.2014 at about 21:45 hours behind Chinpai Petrol Pump, P.S. Sadaipur, Dist.Birbhum made preparation for committing dacoity armed with iron rod, hackshaw, iron dragger etc. and that you thereby committed an offence punishable Under Section **399** I.P.C., and within the cognizance of this Court.

Secondly, You all on 14.03.2014 at about 21:45 hours behind Chinpai Petrol Pump, P.S. Sadaipur, Dist.Birbhum were one of the five or more persons assembled for the purpose of committing dacoity armed with iron rod, hackshaw, iron dragger etc. and that you thereby committed an offence punishable Under Section **402** I.P.C., and within the cognizance of this Court.

And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused persons in Bengali to which he pleaded not guilty and claimed to be tried.

Charge is accordingly framed with two head under Section-399/402 of IPC against accused Subrata Pal, Binoy Das, Baban Bagdi, Samir Bagdi, Abbas Sk. and Farid Sk. in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused persons in Bengali to which the accused persons pleaded not guilty by saying "Amra Nirdosh" and claimed to be tried.

Prosecution is to see that summons upon the said witnesses are issued accordingly.

Witnesses are directed to be present accordingly and for non-compliance of the same provision of section 350 of the Code of Criminal Procedure will be followed.

The I.O is hereby directed to be remained present during entire schedule by producing every witness.
