accused person hereby charge you 1.Jummatun Bibi @ Tajkira Bibi, 2. Kabita Bibi @ Mus takima Khatun, 3. Mina Bibi @ Umeshasalama Bibi, 4. Taslima Khatoon, 5. Sk. Rejaul @ Rezaul Sekh, 6. Hasan Mallick @ Rustam Mallick and 7. Chikai Mallick @ Mustakim Mallick.

as follows -

Firstly : that you all in furtherance of common intention on 07.09.2025 at about 05:30 p.m in the afternoon, illegally entered into the house of defacto complainant of this case and thereby you all committed an offence punishable under Section 329(4)/3(5) of BNS and within the cognizance of this court.

Secondly : that you all in furtherance of common intention on the said date, time and place caused voluntarily hurt on the person of defacto complainant and her minor daughter and thereby you all committed the offence punishable under Section 115(2)/3(5) of BNS and within the cognizance of this court.

Thirdly : that you all on the same date, time and place in furtherance of common intention criminal intimidated the defacto complainant and her minor daughter by threatening t hem to kill them if they take any legal step against them and thereby you all committed the offence punishable under Section 351(2)/3(5) of BNS and within the cognizance of this court.

Fourthly : that you Sk. Rejaul @ Rezaul Sekh, Hasan Mallick @ Rustam Mallick and Chikai Mallick @ Mustakim Mallick on the same date, time and place sexually assaulted the minor daughter of defacto complainant of this case and thereby you all committed the offence punishable under Section 8 of POCSO Act and within the cognizance of this court.

Fifthly : that you Jummatun Bibi @ Tajkira Bibi, Kabit a Bibi @ Mustakima Bibi, Mina Bibi @ Umeshasalama Bibi and Taslima Khatun all in furtherance of common intention abetted Sk. Rejaul, Hasan Mallick and Chikai Mallick to cause sexual assault upon the minor daughter of defacto complainant and thereby you all committed the offence punishable under Section 8/17 of POCSO Act and within the cognizance of this court.

And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.

The accused persons, namely, Jummatun Bibi @ Tajkira Bibi, Kabita Bibi @ Mus takima Khatun, Mina Bibi @ Umeshasalama Bibi, Taslima Khatoon, Sk. Rejaul @ Rezaul Sekh, Hasan Mallick @ Rustam Mallick and Chikai Mallick @ Mustakim Mallick on Court bail are present.

Ld. Spl. P.P and the Ld. Advocate for the accused persons are present.

The defacto complainant files hazira.

Now, the record is taken up for consideration of charge.

After hearing both sides and on perusal of the materials on record, I find that a prima facie case under Section-329(4)/115(2)/351(2) of BNS and Section 8 and 8/17 of POCSO Act against accused Jummatun Bibi @ Tajkira Bibi, Kabita Bibi @ Mus takima Khatun, Mina Bibi @ Umeshasalama Bibi, Taslima Khatoon, Sk. Rejaul @ Rezaul Sekh, Hasan Mallick @ Rustam Mallick and Chikai Mallick @ Mustakim Mallick has been established. Charge is accordingly framed with fifthly head under 329(4)/115(2)/351(2) of BNS and Section 8 and 8/17 of POCSO Act against accused Jummatun Bibi @ Tajkira Bibi, Kabita Bibi @ Mus takima Khatun, Mina Bibi @ Umeshasalama Bibi, Taslima Khatoon, Sk. Rejaul @ Rezaul Sekh, Hasan Mallick @ Rustam Mallick and Chikai Mallick @ Mustakim Mallick in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused persons in Bengali to which the accused persons pleaded not guilty by saying “Amra Nirdosh” and claimed to be tried.

Fix 17.03.2026 for evidence of CSW No. 1, 6 and 7.

Prosecution is to see that summons upon the said witnesses are issued accordingly.

Witnesses are directed to be present accordingly and for non-compliance of the same provision of section 350 of the Code of Criminal Procedure will be followed.

The I.O is hereby directed to be remained present during entire schedule by producing every witness.
