accused person hereby charge you **1. Ajit Kora**

as follows -

Firstly : That the accused person gave bad proposal to the minor daughter of the defacto complainant and on 18.03.2003 when her daughter came out from her house then the accused person kidnapped her aiming to deprive the guardian of custody and thereby committed an offence punishable under Section 363 of IPC and within the cognizance of this court.

Secondly. : That the accused person gave bad proposal to the minor daughter of the defacto complainant and on 18.03.2003 when her daughter came out from her house then the accused person kidnapped her from the lawful guardianship and you kidnapped the minor girl with the intent that she will be forced or seduced to illicit intercourse and you thereby committed an offence punishable u/s-366 of IPC and within the cognizance of this court.

Thirdly. : That the accused person gave bad proposal to the minor daughter of the defacto complainant and on 18.03.2003 when her daughter came out from her house then the accused person kidnapped her from the lawful guardianship and you kidnapped the minor girl with the intent that she will be forced or seduced to illicit intercourse and you thereby committed an offence punishable u/s-366A of IPC and within the cognizance of this court.

Fourthly : That the accused person gave bad proposal to the minor daughter of the defacto complainant and on 18.03.2003 when her daughter came out from her house then the accused person kidnapped her from the lawful guardianship and you kidnapped the minor girl with the intent that she will be forced or seduced to illicit intercourse and forcibly raped her and that you thereby committed an offence punishable Under Section **376** I.P.C., and within the cognizance of this Court.

And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused person in Bengali to which he pleaded not guilty and claimed to be tried.

The accused person, namely, **Ajit Kora** is produced from j/c through V.C and remanded to j/c till date.

Ld. Spl. P.P is present.

Ld. Advocate for the accused person is present.

The record is taken up for consideration of charge.

Heard both sides regarding consideration of charge. After hearing both sides and on perusal of the materials on record, I find that a prima facie case under Section 363/366/366A/376 of IPC against accused Ajit Kora has been established. Charge is accordingly framed with four head under Section 363/366/366A/376 of IPC against accused Ajit Kora in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused person in Bengali to which the accused person pleaded not guilty by saying "Ami Nirdosh" and claimed to be tried.

Fix 31.01.2026 for evidence of defacto complainant and the victim girl.

Prosecution is to see that summons upon the said witnesses are issued accordingly.

Witnesses are directed to be present accordingly and for non-compliance of the same provision of section 350 of the Code of Criminal Procedure will be followed.

The I.O is hereby directed to be remained present during entire schedule by producing every witness.
