COPY OF ORDER

The record is placed before this Court by put up petition.

Accused Mousumi Singha appears before this court voluntarily by filing a petition along with Vokatnama, copy of final assessment bill and receipt showing full payment of outstanding amount with affidavit praying for bail on the ground stated therein. She is taken into custody and remanded to J/C till 31.07.2021.

Ld. PP in charge is present.

Now the bail petition filed by accused is taken up for hearing.

Heard both sides.

Ld. Lawyer for the accused submits that the accused has already paid her entire outstanding amount of the final assessment bill and prays for bail. He also submits by filing an affidavit on behalf of the accused that no application is pending or rejected before any higher forum in connection with this case. Ld. Advocate for the accused also submits by filing an affidavit that the hand writing of amount of final assessment bill was written on the receipt of the WBSedCL by the official of concerned department and undertakes to produce the said receipt by authentication of said hand writing in respect of amount of final assessment bill by office of concerned department if situation arises.

Ld. P.P in charge does not oppose the bail prayer.

On perusal of the same, I find that the accused Mousumi Singha has already deposited entire outstanding amount of Rs.67,645/-. In support of his contention, copy of final assessment bill and receipt have been filed by the accused. Besides this, charge sheet has been submitted.

In view of the above circumstances as well as submission of both sides, I am inclined to enlarge the accused Mousumi Singha on bail. Hence prayer for bail is allowed. The accused Mousumi Singha finds a bail of Rs.1,000/- with one surety i.d. to J/C.

The accused is directed to produce the said receipt by authentication of said hand writing in respect of amount of final assessment bill by office of concerned department within 10 days from this order.

The AE & SM of Murarai CCC, WBSedCL is also directed to authenticate the hand writing of the amount of final assessment bill on the receipt of WBSedCL if it was done by the official of concerned department.

To-date i.e. 04.12.2021 for appearance of above accused if on bail and E/R of W/A in respect of accused Md.Sufi and Meheub Jaman.

Let a copy of this order be sent to the AE & SM, Murarai CCC, WBSedCL and accused.
