The record is placed before this court on this day. The accused person, namely, Sk. Parvej Alam @ Parwaj voluntarily surrenders before this court on the basis of put up petition.

The put up petition is considered and allowed.

The surrender of the accused is hereby accepted. He is taken into custody and remanded to J.C.

One bail petition also has been filed by the Ld. Advocate along with vokalatnama for releasing the accused on bail on the ground stated therein. Let it be kept with the record.

Perused the bail petition along with the record. Heard Ld. Advocate for the accused. Heard the Ld. P.P.-in-Charge.

Ld. Advocate for the accused submits before this court that the accused voluntarily surrenders before this court and further submits that the instant case has been culminated in the charge sheet in the year 2019 showing the above named accused as absconder. It is further contended by the Ld. Advocate that the accused is presently a resident of Bangalore and also files photo copy of his Aadhaar Card to substantiate his contention. Ld. Advocate further submitted that the accused has/had no knowledge as regards to the initiation of the instant case against him and finally submitted that if the accused be released on bail he would remain present before this Court in all further proceedings and accordingly, prays for releasing the accused on bail by imposing any condition.

Ld. P.P.-in-Charge did not raise any objection against the instant bail prayer and fairly submitted that the other co-accused of this case had been previously enlarged on bail and accordingly left the matter before this Court for passing necessary order.

Considering the rival submissions of both sides and on perusal of the record, it reveals that the instant case has been culminated in filing of charge sheet against the above named accused person along with others vide CS no. 96/19 dated 31.12.2019. We know that filing of charge sheet is a substantive development in the course of investigation and there is a bleak possibility as regards to the tamper of prosecution evidence. There is no necessity of custodial interrogation and or no any prayer necessitating further detention of the accused from the side of the prosecution. So, further detention of the accused would yield no fruitful result.

In view of the above circumstances I am inclined to enlarge the accused on bail.

Accused person, namely, Sk. Parvej Alam @ Parwaj may find bail of Rs. 10,000/- with two registered sureties of Rs. 5,000/- each one must be local subject to the satisfaction of Ld. C.J.M., Suri, Birbhum i.d. to J.C with a condition that the accused will remain present in all further proceeding in connection with this case.

If on bail to dated 18.05.2023 for appearance, ER of W/A of Sk Jamir Hossain, Mansur Alam and Sadhan Bauri and awaiting death report of Sk Khelafat.

Re-call W/A at once.

Let a copy of this order be sent to the Ld. C.J.M., Suri, Birbhum with a request to accept the bail bond if submits and after accepting the bail bond, return the bail bond to this Court for keeping the same for future reference.

Let another copy of this order be sent to the I.O. for his information and necessary action.
