The application u/s 483 of BNSS is moved by the Ld. Advocate praying for bail of the petitioner, namely, Sk Piyarul in connection with Dubrajpur P.S. Case No.261 of 2025 dated 30.06.2025 u/ss 310(4)/ 310(5) of BNS, giving rise to G.R. Case No.500 of 2025 of the Court of Ld. Judicial Magistrate, Dubrajpur, Birbhum.

An affidavit has been filed by Sekh Sabu Bakkar, Tadbirkarak of this case stating that no such bail application under section 483 of BNSS has been filed, nor any application is rejected by any higher forum.

Ld. Advocate for the petitioner submits that he is suffering detention since 13/02/2026 and that he has misused the liberty of bail but undertakes now to attend the Court diligently. On above plea, Ld. Advocate for the petitioner prays for admission of the petitioner on bail on any terms and conditions as the Court thinks fit and proper.

Ld. PP-in-charge, Birbhum has raised usual objection and furnished the CD for my perusal.

I have heard both sides.

Perused the C.D. and also the T.C.R.

In view of period of detention of the petitioner and no immediate chance of commitment of the case record he is admitted on bail. Accordingly, prayer for bail is considered and **allowed**.

Hence, it is,

Ordered,

that accused/petitioner, namely, Sk Piyarul, may find bail of Rs.3,000/- with two **fresh** sureties of Rs.1500/- each, subject to the satisfaction of Ld. Judicial Magistrate, Dubrajpur, Birbhum, in default to J/C **with condition to remain present on each and every date fixed**.

Let a copy of this order along with T.C.R. of G.R. 500 of 2025 be sent to the Ld. Judicial Magistrate, Dubrajpur, Birbhum.

Let another copy of this order be also sent to the Superintendent of Suri District Correctional Home, Birbhum for being communicated to the petitioner.
