The application u/s 483 of BNSS is moved by the Ld. Advocate praying for bail of the petitioners, namely, 1. Dharam Hazra and 2. Jhoton Hazra @ Kunai in connection with Dubrajpur P.S. Case No.468 of 2025 dated 26.12.2025 u/ss 85/80(2)/ 108 of BNS, giving rise to G.R. Case No.891 of 2025 of the Court of Ld. Judicial Magistrate, Dubrajpur, Birbhum.

An affidavit has been filed by Krishna Kanta Dhar, Tadbirkarak of this case stating that no such bail application under section 483 of BNSS has been filed, nor any application is rejected by any higher forum.

Ld. Advocate for the petitioners submits that the petitioners have been falsely implicated in this case and if the petitioners are released on bail, they will not abscond and will face the trial. He also submits that charge sheet has already been submitted. Ld. Lawyer for the petitioners further submits that the petitioners are facing custody for 75 days. On above plea, Ld. Advocate for the petitioners prays for admission of the petitioners on bail on any terms and conditions.

Ld. PP-in-charge, Birbhum has raised objection and produced the CD for my perusal.

I have heard both sides.

Perused the C.D and also the T.C.R.

It is observed from the record that the petitioners are suffering in J.C for 75 days. Charge sheet has already been submitted. This Court is of the view that no further development may take place by keeping the petitioners behind the bar. Considering all these aspects, I am inclined to enlarge the petitioners on bail. Accordingly, prayer for bail is **allowed**.

Hence, it is,

Ordered,

that accused/petitioners, namely, 1. Dharam Hazra and 2. Jhoton Hazra @ Kunai, may find bail of Rs.10,000/- each with two sureties of Rs.5,000/- each, subject to the satisfaction of Ld. Judicial Magistrate, Dubrajpur, Birbhum, in default to J/C.
