Today is fixed for consideration of charge.

The accused persons namely **1. Sk Bhutu @ Haider Ali, 2. Jamirul Islam @ Sk, 3. Mojammel Haque, 4. Sekender Hossain @ Rasidul 5. Kamrul Hossain @ Hasan, 6. Nur Mohammad & 7. Sk Sahidul** on bail are present by filing hazira.

Ld.Panel-PP and Ld.Defence Counsel are present.

The case record is taken up for consideration of charge.

Heard both sides.

Perused the C.D along with other materials on record.

Ld.Panel-PP opens his case by describing that on 18.06.2020 in the evening at around 06:30 P.M. these accused persons in furtherance of common intention of all entering into the house of Amina Khatun gave blow of tangi on the head of Abdul Alim and assaulted him with iron rod, wooden stick, hasua. After that they attacked upon Abul Kalam and Nihara Khatun with iron rod and wooden stick. Thereafter they assaulted Sk Enamul, brother of Abdul Alim, with iron rod and wooden stick resulting fracture injury on his hand. They also assaulted Abul Hasim @ Apel with iron rod. All of them were admitted in Suri Sadar Hospital. Ld.Panel-PP also describes the witnesses to be examined and the documents to be proved.

Ld.advocate for the defence raises objection.

Having considered the materials on record and submission of both sides, this court is of the opinion that there is ground for presuming that the accused persons have committed offences punishable u/s 448, 324 read with section 34, 326 read with section 34 and 307 read with section 34 IPC and accordingly, charge is framed against the accused persons.

The contents of said charges are read over and explained in Bengali to the accused persons and on being asked whether they plead guilty or claim to be tried, each of these accused persons plead not guilty by saying – “AMI NIRDOSH” (innocent) and claims to be tried. Accordingly the case is adjourned.
