Ld. Special Public Prosecutor submits that one witness Sourav Pal is present.

Ld. Advocate for the defence, however, apprised the Court about the resolution of the Local Bar Association dated 10.01.2022 and the directions of the Hon'ble Court communicated vide letter of the Ld. Registrar General dated 13.01.2022 in view of the rapid rise of Covid-19 cases in the 3rd wave of the pandemic.

The Hon'ble Court by its directions communicated vide letter dated 13.01.2022, which is effective till 31.0.2022, has directed that "No hearing matters will be ordinarily taken up. Only criminal appeals of the convicts in custody, applications for suspension of sentence and bail applications shall be listed on regular basis."

This Court is of the view that keeping in mind of the worsening of the pandemic situation in this district, a date should be fixed for fixing further date of evidence after assessment of the Covid-19 pandemic position.

Considering the aforesaid circumstances and the directions of the Hon'ble Court, the matter is fixed on **14.02.2022** for production of accused Safiul Alam and fixing of further date of evidence.
