Received Dubrajpur P.S Case No. 76 of 2024 dt. 11.03.2024 along with two accused challans, forwarding report, written complaint, two seizure lists and two arrest-cum-inspection memo. Let it be kept with the record.

Two accused persons, namely, Sandip Das and Swapan Das are produced from J/C.

Seen.

The case is registered as Spl(P) Case No. 14 of 2024.

The Ld. Advocate for the accused person, namely, Swapan Das files an application for bail and submits that this accused being the father of the principal accused did nothing and no reason is there to arrest and detain him in custody since he did nothing.

Being heard both sides and after perusal the materials on record and in C.D, it appears to me that this accused may be entangled for the purpose of Section 17 of POCSO Act for abatement, if any. But there is no whispering in the C.D whether this accused arranged any vehicle or not and no vehicle number also mentioned in the original written complaint as well as in the C.D. In view of the situation, I am inclined to release the accused person, namely, Swapan @ Swapan Kr. Das on furnishing a bail bond of Rs.1,000/- with one surety i.d. to J/C till 26.03.2024/27.03.2024.

To 27.03.2024 for appearance of the accused Swapan @ Swapan Kr. Das.

One prayer for P.C. of the accused person, namely, Sandip Das @ Sandy for five days is made by the I.O. and duly certified by C.I of police Sadar B. Circle, Dubrajpur, Birbhum.

The petition for P/C is taken up for consideration.

Perused the prayer of P/C which was certified by the C.I of police Sadar B. Circle, Dubrajpur, Birbhum.

On perusal of case record and C/D it shows that P.C. is necessary for the sake of investigation. Accordingly, the prayer for P/C for one day is allowed.

The accused person, namely, Sandip Das @ Sandy is remanded to P/C. He will be produced before this Court on 13.03.2024.

I.O. shall take care of the accused person and shall follow the verdict of the Hon'ble Apex Court in respect of Police Custody.

The accused person, namely, Sandip Das @ Sandy be handed over to the I.O. after obtaining the signature of the accused person and I.O.

One prayer is also made by the I.O for the medical examination (potency test) of the accused person, namely, Sandip Das @ Sandy.

Prayer for medical examination of the accused is taken up for hearing.

Heard. Considered.

The prayer of the I.O. in respect of medical examination (potency test) of accused person, namely, Sandip Das @ Sandy is allowed.

Superintendent, Suri Sadar Hospital, Suri, Birbhum is directed to make necessary arrangement for medical examination of the accused person, namely, Sandip Das @ Sandy.
