And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused person in Bengali to which he pleaded not guilty and claimed to be tried.

The record is fixed for production and charge.

Both the accused persons, namely, Sandip Das @ Sandy and Swapan Kr. Das on Court bail are present.

After hearing both sides and on perusal of the materials on record, I find that a prima facie case under Section-6 of POCSO Act against accused Sandip Das @ Sandy and Section-17 of POCSO Act against accused Swapan Kr. Das has been established. Charge is accordingly framed with one head under Section-6 of POCSO Act against accused Sandip Das @ Sandy and one head under Section-17 of POCSO Act against accused Swapan Kr. Das in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused persons in Bengali to which the accused persons pleaded not guilty by saying "Amra Nirdosh" and claimed to be tried.
