The application u/s 482 of BNSS is moved by the Ld. Advocate praying for anticipatory bail of the petitioner, namely, Jalal @ Samsuddin Sekh, in connection with Dubrajpur PS case No.136 of 2026 dated 20.04.2026 u/s 126(2)/ 132/ 221/ 109(1)/ 121(2)/ 303(2)/ 317(2)/ 317(3)/ 317(4)/ 317(5)/ 351(2)/ 3(5) of BNS, giving rise to G.R Case No.261 of 2026 of the Court of Ld. Judicial Magistrate, Dubrajpur, Birbhum.

An affidavit has been filed by Jalal @ Samsuddin Sekh, the petitioner himself of this case stating that no such bail application under section 482 of BNSS has been filed, nor any application is rejected by any higher forum.

Accordingly, the IO of this case namely, PSI, Tarun Roy of Dubrajpur PS is directed to appear personally before this Court justifying his report in view of the material contained in the CD, so that the Court may get clear picture regarding the actual involvement of the petitioner in this instant case.
