Considering the rival submission of the Ld. Advocate of both sides and on perusal of the record it reveals that the instant case has been culminated in filing charge sheet against the accused person and this Court was pleased to enlarge the accused person on bail.

It is the settled law that filing of charge sheet is a substantive development in the course of investigation and when the charge sheet has been submitted after completion of investigation, I find further detention of the accused person would yield no fruitful purpose. There is no prayer for necessity of custodial interrogation or any other prayer necessitating further detention of the accused person from the side of the prosecution.

In view of the above circumstances, I am inclined to enlarge the accused person on bail.

Accused person persons, namely, Sk Ali Monsur may find bail of Rs. 2,000/- with one surety to the satisfaction of Ld. C.J.M., Suri, Birbhum i.d. to J.C.
