6. Ramesh Bagdi and 7. Laxmi Bagdi

as follows -

Firstly : That the marriage of his daughter took place with Sukumar Let @ Bokul out of love affairs and after marriage she used to stay in the house of the accused persons and then all of you physically and mentally tortured her on demand of money and thereby treated her with cruelty and thereby all of you committed an offence punishable Under Section **498A/34** I.P.C. and within the cognizance of this Court.

Secondly : That the marriage of his daughter took place with Sukumar Let @ Bokul out of love affairs and after marriage she used to stay in the house of the accused persons and then all of you physically and mentally tortured her on demand of money and thereby treated her with cruelty and instigated her to commit suicide by hanging and thereby you committed an offence punishable Under Section **306/34** I.P.C. and within the cognizance of this Court.

Thirdly : That the marriage of his daughter took place with Sukumar Let @ Bokul out of love affairs and after marriage she used to stay in the house of the accused persons and then all of you physically and mentally tortured her on demand of money and thereby treated her with cruelty and instigated her to commit suicide by hanging and ultimately on 03.02.2022 at about 5:00 p.m defacto complainant got information that the accused person committed dowry death of his daughter and that you thereby committed an offence punishable Under Section **304B/34** I.P.C. and within the cognizance of this Court.

And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.

Today is fixed for production and for consideration of charge.

The accused persons, namely, Sukumar Let @ Bokul, Bablu Let, Kajali Let, Chobi Let, Chinta Bagdi @ Chumki, Ramesh Bagdi and Laxmi Bagdi on court bail are present.

Ld. Spl. P.P is present.

Ld. Advocate for the accused person is present.

The record is taken up for consideration of charge.

Heard both sides regarding consideration of charge. After hearing both sides and on perusal of the materials on record, I find that a prima facie case under Section 498A/306/304B/34 against accused Sukumar Let @ Bokul, Bablu Let, Kajali Let, Chobi Let, Chinta Bagdi @ Chumki, Ramesh Bagdi and Laxmi Bagdi has been established. Charge is accordingly framed with three head under Section 498A/306/304B/34 against accused Sukumar Let @ Bokul, Bablu Let, Kajali Let, Chobi Let, Chinta Bagdi @ Chumki, Ramesh Bagdi and Laxmi Bagdi in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused persons in Bengali to which the accused persons pleaded not guilty by saying "Amra Nirdosh" and claimed to be tried.

Fix 20.12.2025 for evidence of CSW No. 1.

Prosecution is to see that summons upon the said witnesses are issued accordingly.

Witnesses are directed to be present accordingly and for non-compliance of the same provision of section 350 of the Code of Criminal Procedure will be followed.

The I.O is hereby directed to be remained present during entire schedule by producing every witness.
