Tiya Bibi, 4. Sk. Altab and 5. Sk. Ataul

as follows -

Firstly : That the marriage of the daughter of the defacto complainant took place with Sk. Abbas three years ago and after marriage her daughter used to stay in the house of the accused persons and then all of you physically and mentally tortured her and you all thereby committed an offence punishable Under Section **498A/34** I.P.C. and within the cognizance of this Court.

Secondly : That the marriage of the daughter of the defacto complainant took place with Sk. Abbas three years ago and after marriage her daughter used to stay in the house of the accused persons and then all of you physically and mentally tortured her and on 31.12.2019 at 8:00 p.m set fire on her body by pouring kerosene oil and caused her burnt injury and attempted to murder her by setting fire on her body and thereby you have intention and knowledge that if you do that act you will be guilty of murder and that you thereby committed an offence punishable Under Section **307/34** I.P.C., and within the cognizance of this Court.

And I hereby direct that you be tried by the said Court on the said charge. The contents of the said charge is read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.

Today is fixed for production and for consideration of charge.

The accused persons, namely, Sk Abbasuddin @ Sk Abbas, Ujala Bibi, Tiya Bibi, Sk. Altab and Sk. Ataul on court bail are present.

Ld. Spl. P.P is present.

Ld. Advocate for the accused person is present.

The record is taken up for consideration of charge.

Heard both sides regarding consideration of charge. After hearing both sides and on perusal of the materials on record, I find that a prima facie case under Section 498A/307/34 of IPC against accused Sk Abbasuddin @ Sk Abbas, Ujala Bibi, Tiya Bibi, Sk. Altab and Sk. Ataul has been established. Charge is accordingly framed with two head under Section 498A/307/34 of IPC against accused Sk Abbasuddin @ Sk Abbas, Ujala Bibi, Tiya Bibi, Sk. Altab and Sk. Ataul in prescribed form which be tagged with the record. The contents of the charge is read over and explained to the accused persons in Bengali to which the accused persons pleaded not guilty by saying "Amra Nirdosh" and claimed to be tried.

Prosecution is to see that summons upon the said witnesses are issued accordingly.

Witnesses are directed to be present accordingly and for non-compliance of the same provision of section 350 of the Code of Criminal Procedure will be followed.
