The application u/s 482 of BNSS is moved by the Ld. Advocate praying for anticipatory bail of the petitioners, namely, (1) Biki Ghosh and (2) Alimuddin Mondal @ Alimuddin Sk in connection with Murarai P.S. Case No.185 of 2026 dated 23.06.2026 u/s 117(2)/ 118(2)/ 329(4)/ 74/ 351(2)/ 3(5) of BNS, giving rise to G.R. Case No.1638 of 2026 of the Court of Ld. Additional Chief Judicial Magistrate, Rampurhat, Birbhum.

An affidavit has been filed by Biki Ghosh, one of the petitioners of this case stating that no such bail application under section 482 of BNSS has been filed, nor any application is rejected by any higher forum.

Ld. Advocate for the petitioners submits that the petitioners have been falsely implicated in this case and if the petitioners are released on bail, they will not abscond and will cooperate with the process of law. Ld. Lawyer for the petitioners further submits that the alleged sections are inserted in the FIR is an abuse of process of law. On above plea, Ld. Advocate for the petitioners prays for admission of the petitioners on anticipatory bail on any terms and conditions as the Court thinks fit and proper.

Ld. PP-in-charge, Birbhum has raised objection and furnished the CD for perusal.

I have heard both sides.

Perused the C.D and also the T.C.R.

The defacto complainant lodged the complaint to the effect that on 17.06.2026 at about 08:30 A.M her husband and daughter were in their house at that time the accused persons out of previous grudge entered into their house and physically assaulted her husband and her pregnant daughter and kicked her daughter's abdomen and outraged the modesty of her daughter.

At the time of perusing the materials on CD, it appears that there is not clearly mentioned whether an X-ray of the pregnant injured was done or not.

Let the latest report be called for from the IO. The hearing of this case is put on hold till the next date fixed.

IO is directed to collect latest injury report (X-ray report of the pregnant victim) to ascertain any injury sustained by the victim or not and also directed to submit a clear report regarding present condition of the pregnant victim.

CD and TCR be returned.

Call for TCR and CD along with latest injury report, if any.
