Today is fixed for hearing of the petition dt. 03.03.2020 and also of the application filed under Section 25 of Guardian and Wards Act.

Both parties are present.

The petition dt. 03.03.2020 is taken up for hearing.

It appears that the petition has been filed by the petitioner praying for conducting the case in person. The petitioner himself is a Ld. Advocate practicing at Calcutta High Court. Accordingly, the prayer is allowed and the petition dt. 03.03.2020 is thus disposed of.

At the time of hearing, Ld. Advocate for the opposite party submits that another petition dt. 15.11.2022 is pending for hearing and written objection has not yet been filed by him.

Perused the record. It appears that the application dt. 15.11.2022 has been filed by the petitioner for non compliance of the order dt. 22.08.2022 passed by this Court by the opposite party. The copy of the said petition has been supplied to the OP.

Hence, fix 29.07.2023 for hearing of the petition dt. 15.11.2022 and the opposite party is at liberty to file written objection, if any, in the meantime.

This day another petition filed on behalf of the petitioner praying for passing necessary direction upon the Head Mistress of Kishalay Nursery School, Bolpur (which is opposite to Bolpur Girls High School) so that petitioner could distribute gifts to the classmates of his daughter namely Miss Saranya Mukherjee (who is reading in Class-IV of that school) on the eve of her birthday i.e. on 06.04.2023.

The Ld. Advocate appearing on behalf of the opposite party raised no objection if the said prayer is allowed.

Accordingly, the prayer is allowed. Petitioner, being father, is at liberty to distribute the gifts to the classmates / friends of his daughter on the eve of her birthday i.e. on 06.04.2023 in presence of the mother and the Head Mistress of Kishalay Nursery School, Bolpur (opposite to Bolpur Girls High School).

Inform both parties.

Let a copy of this order be communicated to the Head Mistress of Kishalay Nursery School, Bolpur (opposite to Bolpur Girls High School) for compliance.
