Today is fixed for appearance of **four (04)** accused persons, production of accused Anamat Palowan and E.R of W.P.A of **six (06)** accused persons namely Atikul Rahaman, Sk. Jiarul, Sk. Raju, Sk. Amjad, Lalbabu Momin and Sk. Azad.

Ld. PP, Birbhum is present.

Three **(03)** accused persons namely Sk. Iliyash, Sk. Mustak Ahammed @ Papu and Nur Islam Mondal, on Court bail, are present today by filing hazira and prays for confirmation of their interim bail.

Prayer for confirmation of their bail is considered and allowed.

Accused Anamat Palowan is produced from J.C on the strength of production warrant. He is taken into custody and remanded to J.C till next date.

Ld. Advocate, LADCS, Birbhum has represented the accused Anamat Palowan.

Record reveals that accused Anamat Palowan was on interim bail at the time of issuance of his production warrant. His prayer for confirmation of interim bail filed by Ld. Advocate, LADCS, Birbhum is also considered and allowed.

No E.R of W.P.A against five **(05)** accused persons namely Atikul Rahaman, Sk. Jiarul, Sk. Raju, Sk. Amjad and Lalbabu Momin is received till date.

They are declared proclaimed offender and the case is filed for present against five (05) accused persons namely Atikul Rahaman, Sk. Jiarul, Sk. Raju, Sk. Amjad and Lalbabu Momin for the time being.

On behalf of accused Mithu Palowan a petition is filed for issuance of production warrant as he is suffering detention in connection with GR case no. 731/2012 at Suri District Correctional Home.

Issue production warrant against accused Mithu Palowan at once with direction upon the Superintendent of Suri District Correctional Home to cause his appearance through V.C.

One accused Sk. Azad has surrendered today by petition. He is taken into custody and remanded to J.C till date.

Copy of bail petition is served upon Ld. PP, Birbhum.

Since the case is now ready for transfer and disposal, the accused Sk. Azad is admitted on bail of **Rs.5000/- with two fresh registered sureties of Rs.2500/- each**, subject to satisfaction of Ld. CJM, Birbhum at Suri on condition to attend before the Ld. Transferee Court on the date fixed.
