Today is fixed for appearance of two (02) accused persons, production of accused Md. Khairul Alam @ Kata and E.R of W.A of five (05) accused persons.

Out of seven (07) accused persons, on Court bail, two (02) accused persons namely Sk. Ujjwal and Sk. Nurul @ Sk. Naru are present by filing hazira and prays for extension of their interim bail.

Prayer for extension of interim bail is allowed.

Accused Md. Khairul Alam @ Kata is produced from J.C. He is taken into custody and further remanded to J.C till next date. A fresh vokalatnama is filed on behalf of him.

Ld. Advocate for the accused Md. Khairul Alam @ Kata files a petition praying for bail of the accused person.

Considering the materials on record, period of detention in custody for 200 days and the stage of proceeding awaiting initiation of trial, I am inclined to enlarge the accused on interim bail. Accordingly, the prayer for bail of the accused is allowed.

that the accused Md. Khairul Alam @ Kata may find bail of **Rs.1,000/-** with one fresh sureties of like amount, subject to the satisfaction of Ld. Chief Judicial Magistrate, Suri, Birbhum, i.d to J.C till next date. If on bail the accused is directed to appear before this Court on the date fixed, i.e. on 24.02.2026.
